#### Mission of the Universal Postal Union

To stimulate the lasting development of efficient and accessible universal postal services of quality in order to facilitate communication between the world's inhabitants by:

- guaranteeing the free circulation of postal items over a single postal territory composed of interconnected networks;
- encouraging the adoption of fair common standards and the use of technology;
- ensuring cooperation and interaction among stakeholders;
- promoting effective technical cooperation;
- ensuring the satisfaction of customers' changing needs.

#### Vision

The postal sector is seen as an essential component of the global economy.









Goal

Improve the interoperability of the international postal networks

#### **Programmes:**

- 1.1 Enhance quality of service, reliability and efficiency of the postal networks
- 1.2 Increase postal integrity and security and facilitate customs processes
- 1.3 Develop adequate standards and regulations
- 1.4 Stimulate the use of information and communication technologies to improve access and performance
- 1.5 Promote addressing in national postal systems

 Provide technical knowledge and expertise related to the postal sector

#### **Programmes:**

- 2.1 Increase awareness of the role of the postal sector
- 2.2 Strengthen members' capacity to implement and manage their universal service
- 2.3 Provide market and sectoral research in response to customer and stakeholder needs
- **2.4** Develop statistical and analytical/cost accounting procedures
- 2.5 Provide information and expertise to foster cooperation among stakeholders

- 4.1 Improve remuneration systems between designated postal operators

- 4.4 Promote environmental awareness, social responsibility and resilience to disasters




## D UNIVERSAL POSTAL UNION

## CA Ensure the continuity of the work of the Union between Congresses according to the Acts

- To supervise the activities of the Union between Congresses
- To consider and approves any action considered necessary to safeguard and enhance the quality of and to modernize the international postal service
- To promote, coordinate and supervise all forms of postal technical assistance
- To consider and approve the UPU Programme and Budget and the accounts of the Union
- To oversight the relations between the UPU and other international organizations
- To establish principles, for the POC to take into account in its study of questions with major financial repercussions
- To monitor the implementation of the draft Strategy and develop the new Strategy

A number of Congress mandates to attain the mission and objectives







# Major challenges of each Committee and Plenary



#### **Committee 1 (Governance and Regulatory issues)**

- Improve the efficiency and productivity of the UPU Reform of the Union
- Develop and establish clear and transparent regulatory rules and principles for the UPU mail exchanges (Multiple DOs, ETOEs, Network and service access policy, etc)
- Refine and modernize the UPU Acts and Regulations
- Conduct studies to establish sound governmental principles on UPU remuneration systems, considering all aspects of universal postal service obligation
- Oversee any regulatory questions regarding the POC activities, particularly postal payment service, USB, etc.
- Monitor and address issues relating to the EU and WTO



#### **Committee 2 (Finance and Administration)**

- Consider and approve the UPU budget and accounts ensuring the most efficient and transparent finance management
- Consider and approve the UPU audit reports
- Lay down the IB Staff Regulations and consider issues regarding the IB's human resources management, including recruitment and employment conditions



#### **Committee 3 (Strategy)**

- Ensure that questions relating to the prioritisation of activities and the allocation of resources to the annual UPU Programme and Budget are dealt with in the most efficient and transparent manner
- Monitor and evaluate the implementation of the DPS by member countries and bodies of the Union to assess the efficient use of resources
- Develop the future draft strategy for 2017 to 2020 to provide clear vision and objectives for the Union



#### **Committee 4 (Development and Cooperation)**

- Implement the UPU development cooperation policy for 2013 to 2016
- Take the necessary steps to implement the decisions taken by Congress concerning the UPU Emergency and Solidarity Fund
- Develop various tools for Posts to reduce any negative impacts on the environment for sustainable development and organize an extensive awareness campaigns on sustainability among all stakeholders
- Leverage sector economic analysis for UPU member countries and build up the IB as an excellence centre of knowledge in postal sector



#### **Plenary**

- Oversee the activities of the POC and the CC
- Promote and oversee the relations between the UPU and other international organizations
- Organize an annual Conference on postal regulation
- Provide high-level guidance and input to Committee work
- Consider any political issues
- Prepare the next Congress

- Creating an open and regular communication channel between the CA Management Committee members, Project Group Chairs and other member countries involved
